

# CITY OF WHITE SALMON

## ORDINANCE NO. 2011-02-863

**AN ORDINANCE OF THE CITY OF WHITE SALMON, WA, REPEALING Ord. 2001-12-722 § 4 (SMC 13.16.030) AND AMENDING Ord. 2008-2-812 § 1 (SMC 13.16.025) CLARIFYING WATER USAGE RATES AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.**

**WHEREAS**, in 2008 the City Council passed Ordinance No. 2008-2-812 § 1 relating to Water and Sewer Rate Schedules, now codified as WSMC 13.16.025; and

**WHEREAS**, pursuant to this Ordinance, the City Council adopted a rate schedule for metered water usage for Single Family Residences, Duplexes or Single Family Lots of Non-Residential Units; and

**WHEREAS**, the Ordinance provides for usage charges at a specified rate, but an earlier ordinance (Ord. 2001-12-722 § 4), codified as SMC 13.16.030 specified a different rate for metered water rate usage; and

**WHEREAS**, the ordinances are inconsistent, and the Council intends the more recently adopted rate to be the operative rate for the City; and

**WHEREAS**, the word “dollars” is missing in paragraph A(2) of Ordinance No. 2008-2-812 § 1 (SMC 13.16.025(A)(2));

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITE SALMON, WASHINGTON DO ORDAIN AS FOLLOWS:** by the City Council of the City of White Salmon that the following amendments be made to White Salmon Municipal Code Chapter 13.16:

### **SECTION 1 – Amendment to WSMC 13.16.025**

Section 13.16.025(A)(2) is hereby amended to read:

Over three thousand gallons: two dollars per one thousand gallons or part thereof.


### **SECTION 2 – Repeal of Ord. 2001-12-722 § 4 (SMC 13.16.030)**

Ord. 2001-12-722 § 4 (SMC 13.16.030) is hereby repealed.

**SECTION 3 - SEVERABILITY.** If any section, sentence, or phrase of this Chapter is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence or phrase of this Chapter.

**SECTION 4 - EFFECTIVE DATE.** This ordinance shall become effective following passage and publication as provided by law.


