## CITY OF WHITE SALMON WASHINGTON ORDINANCE NO. 2016-06-984

# AN ORDINANCE AMENDING VEHICLE CODE SECTION WSMC CH 10.24 REGARDING STOPPING, STANDING AND PARKING, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE

**WHEREAS,** the City Council of the City of White Salmon wishes to maintain the safety and welfare of city residents by regulating stopping, standing and parking of vehicles in the City; and

WHEREAS, the City finds that amendments are necessary to add new provisions and to remove obsolete language to ensure the health and safety of City residents.

NOW, THEREFORE, the City of White Salmon do ordain as follows:

SECTION 1. WSMC Ch. 10.24 is hereby amended as follows:

Added = **bold underlined** 

#### 10.24.160 - Handicapped parking only.

- A. The following two parking spaces are designated as "parking for handicapped only": two spaces on the west side of Main Street south of the intersection with Scenic Street in front of the Whitson Elementary School.
- B. The following two parking spaces are designated as "parking for handicapped only": one space east and one space west of where the walkway from the Park Center Building intersects with the south side of Washington Street.
- C. The following parking space is designated as "parking for handicapped only": one space in the parking area south of the Park Center Building.
- A. The following parking space is designated as parking for handicapped only. One space north side of Jewett Blvd from Main Street East.
- B. The following parking space is designated as parking for handicapped only. One space south side of Jewett Blvd from 1<sup>st</sup> Street West.

### C. <u>The following parking space is designated as parking for handicapped only. First space south</u> side of Jewett Blvd one space east from 1<sup>st</sup> Ave.

- D. The Public Works Director shall have the above parking spaces designated as "Handicapped Parking Only".
- E. Violation of this section shall be a traffic infraction with a penalty of not more than two hundred fifty dollars.

#### 10.24.170 - Back-in parking only.

Beginning at the south east corner of intersection Jewett Blvd and 1<sup>st</sup> Street Avenue traveling east along the south side of Jewett Blvd until reaching the mid-block point of the 200 block of East Jewett Blvd back in parking is the only permitted parking allowed unless otherwise specified by this section.

<u>10.24.180</u> - Back-in parking exception.

Back-in parking as designated in 10.24.170 of this section shall not apply to those parking spaces designated as "Handicapped Parking Only". Handicapped parking spaces within the designated areas described in 10.24.170 shall be marked as parallel parking only.

**SECTION 2- SEVERABILITY:** If any section, sentence, or phrase of this Chapter is held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence or phrase of this Chapter.

**SECTION 3 - EFFECTIVE DATE.** This ordinance shall become effective following passage and publication as provided by law.
