**WHEREAS**, council of the City of White Salmon approved a letter of intent to join into the proposed Emergency Medical Services district as long as the other two cities in Klickitat county agree and the rates is not more than \$.24 per thousand of assessed value on November 7, 2012; and

**WHEREAS**, the Klickitat County Board of County Commissioners request the city follow RCW 36.32.480(2) by adopting a resolution on the matter.


**NOW, THEREFORE, BE IT RESOLVED** that the governing body of the City of White Salmon hereby approves the inclusion of the city limits of the City of White Salmon into the proposed Emergency Medical Services District.

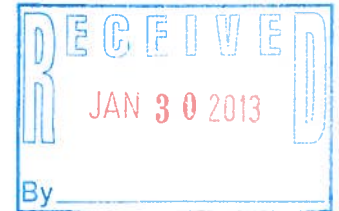
