

CITY OF WHITE SALMON, WASHINGTON

RESOLUTION NO 2017-07-455

A RESOLUTION of the City Council of the City of White Salmon, Washington, relating to regular property taxes; providing for the submission to the qualified electors of the city at a general election to be held on November 7, 2017, of a proposition authorizing the City to levy regular property taxes in excess of the limitations of Ch. 84.55 RCW; and setting forth the text of the ballot proposition.

WHEREAS, in 2012 White Salmon voters approved a temporary lid lift to supplement the city pool for five years. This levy expires in 2017 and there are plans for construction of a new pool, which is not yet complete; and

WHEREAS, the City Council of the City of White Salmon, Washington (the "City") has determined that it is in the interest of the City to extend the temporary levy for an additional year while the new pool plans are finalized; and

WHEREAS, RCW 84.55.050 provides for the levy of regular property taxes in an amount exceeding the limitations specified in chapter 84.55 RCW if such increased levy is authorized by a ballot proposition approved by a majority of the voters at an election held within the taxing district (a "levy lid lift"); and

WHEREAS, the City Council has determined that it is in the best interest of the City and its residents to submit a levy lid lift proposition under RCW 84.55.050(1) to the voters for their approval or rejection;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. Calling of Election. The City Council finds that it is in the best interest of the City to submit to the qualified voters of the City, at the general election to be held on November 7, 2017, a proposition authorizing the City to increase its regular property tax levy for collection in 2018 by an amount greater than otherwise permitted under chapter 84.55 RCW for the purposes described in Section 2(a). If this proposition is approved, the City Council will be authorized to adopt, in accordance with its regular budget process, an increased regular property tax as described in Section 2.

Section 2. Purpose and Description of Ballot Proposition (the "Proposition"). For the purposes identified below, the City Council seeks voter approval under RCW 84.55.050 for a levy lid lift, as follows:

(a) Purpose. The amounts collected pursuant to the increase authorized by the Proposition shall be used to pay for pool operations and maintenance.

(b) Increase Authorized in 2017. The Proposition authorizes a maximum increase in the City's total levy rate to the maximum rate otherwise allowed for collection in 2018 under chapter 84.55 RCW plus not to exceed \$0.18 per \$1,000 of assessed value. The total regular property tax rate produced is estimated to be approximately \$1.289 per \$1,000 of assessed value, based on estimated 2017 assessed values.

Section 3. Ballot Proposition. The Auditor of Klickitat County, Washington (the "Auditor"), as *ex officio* supervisor of elections, is hereby requested to call and conduct an election in the City, in the manner provided by law, to be held on the date identified in Section 2, for the purpose of submitting to the voters of the City, a proposition in substantially the following form:

Single Year Temporary Levy Lid Lift

The City of White Salmon City Council adopted Resolution No. 2017-07-1012 concerning property taxes for pool operations and maintenance. If approved this proposition would authorize the City to set its 2018 regular property tax levy rate at \$1.289 per \$1,000 (an increase of \$0.18 per \$1,000 over the current levy without the prior temporary lid lift) to finance pool operations and maintenance. Should this proposition be:


Section 4. Notices Relating to Ballot Proposition. For purposes of receiving notice of the exact language of the ballot proposition required by RCW 29A.36.080, the City Council hereby designates (1) the Clerk/Treasurer and (2) the City Attorney as the individuals to whom such notice should be provided.

Section 5. Authorization to Deliver Resolution and Perform Other Necessary Duties. The City Clerk is authorized and directed, no later than August 1, 2017, to certify a copy of this resolution to the Auditor and to perform such other duties as are necessary or required by law to the end that the Proposition described herein should appear on the ballot at the special election identified in Section 2 of this resolution.

Section 6. Severability. The recitals stated above (i.e., the "Whereas" clauses) constitute specific findings by the City Council in support of passage of this resolution. If any provision of this resolution is declared by any court of competent jurisdiction to be invalid, then such provision shall be null and void and shall be separable from the remaining provisions of this resolution, and shall in no way affect the validity of the other provisions of this resolution or of any other resolution or resolution, or of the levy or collection of the taxes authorized herein.


