Proposed amendments to the City's CAO Update will be open for public comment starting August 30<sup>th</sup> through September 29th. Local adoption is anticipated November 2023.

As a result of a periodic review of the SMP, amendments to the CAO are proposed to keep it current with amendments to best available science, the recent SMP Periodic Update related to critical areas in shoreline jurisdiction and local guidance regarding administration.




Figure 1. City of White Salmon Zoning Map

Development projects proposed within the City's listed critical areas and/or their buffers must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

Not applicable—such increases not anticipated.

#### 2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The proposed amendments associated with the City's CAO update are not anticipated to appreciably affect plants, animals, fish, or aquatic life. Changes include removing heritage tree provisions from the CAO (currently WSMC 18.10.317) and placing within a new section of Title 18 – Environment. Forested areas, including Oregon white oak woodland and Oak/Pine mixed forested areas would still be protected as priority habitats by the CAO. Otherwise, development projects proposed within the City's listed critical areas and/or their buffers must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

#### Proposed measures to protect or conserve plants, animals, fish, or marine life are:

The proposed amendments to the CAO include (in some circumstances) increased protection for wetlands (and plant and animals within) drawing from in larger buffers over existing regulations, as

well as preventing direct wetland impacts from recreational trails. Otherwise, do not include additional measures to protect or conserve plants, animals, fish, or aquatic life.

## 3. How would the proposal be likely to deplete energy or natural resources?

The proposed amendments associated with the City's CAO are not anticipated to deplete energy or natural resources. The proposed amendments are intended to keep the CAO current with best available science and better administration of the code. Development projects proposed within the City's critical areas and/or their buffers must comply with the City's CAO, the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

## • Proposed measures to protect or conserve energy and natural resources are:

The proposed amendments to the CAO do not include additional measures to protect or conserve energy and natural resources.

# 4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection, such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The proposed amendments associated with the City's CAO do include amendments to wetland regulations to capture best available science. Otherwise, the proposed amendments associated with the City's CAO are not anticipated to affect other environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection. Development projects proposed within the City's critical areas and/or their buffers must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

## • Proposed measures to protect such resources or to avoid or reduce impacts are:

The proposed amendments are intended to keep the CAO current with state guidance for wetland regulations.

# 5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The proposed amendments associated with the City's CAO ensure greater protection for wetlands that may be present, while providing a more robust list of exemptions and allowed uses to limit gray areas within the code. Otherwise, amendments are not anticipated to affect land uses and will not act as regulations within shoreline jurisdiction. Development projects proposed within the City's critical areas and/or their buffers must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

#### • Proposed measures to avoid or reduce shoreline and land use impacts are:

The proposed amendments to the CAO do not include additional measures to avoid or reduce shoreline and land use impacts.

# 6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The proposed amendments associated with the City's CAO update are not anticipated to increase demands on public services and utilities. Proposed amendments are intended to keep the CAO current with best available science and better administration of the code.
