On July 21, 2021, the White Salmon City Council adopted <u>Ord. No. 2021-07-1083</u>, a Temporary Short-Term Rental (STR) Moratorium for a period of time not to exceed six months, unless extended for good cause pursuant to <u>RCW 35.63.200</u>.

The Council held a public hearing on September 1, 2021, and voted unanimously to keep the ordinance in effect, finding that the impacts of STR across the community require additional regulation by the City and directed staff to prepare such regulations (<u>Staff Report</u>, <u>Video</u>, <u>Minutes</u>). Staff has prepared and amended regulations which will be incorporated into Title 17 – Zoning, which thereby requires a SEPA review.
